

## **Hosting24.com Affiliate Agreement**

All affiliate accounts fall under these terms.

This Affiliate Agreement ("Agreement") contains the complete terms and conditions between us, Hostinger International Ltd. (company address 61 Lordou Vironos Street, Lumiel Building, 6023 Larnaca, Cyprus) and you, regarding your application to participate as an affiliate of Hosting24.com ("Affiliate"), and the establishment of links from your website to our website Hosting24.com.

BY SUBMITTING AN APPLICATION TO JOIN OR BY PARTICIPATING IN THE HOSTING24.COM AFFILIATE PROGRAM, YOU ARE CONFIRMING THAT YOU HAVE READ THIS AGREEMENT AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS.

### **Hosting24.com Affiliate Agreement Definitions**

"We", "Our", "Us", - "Hostinger International Ltd.", (collectively, "Hostinger")

"You", "Your" and "Affiliate(s)" - the business, individual or entity applying for participation in the Hostinger Affiliate Program, or that displays Our products, services and/or promotions on its website and/or through offline representation through the affiliate tracking code in exchange for receiving remuneration from Hostinger for sales resulting from such display.

### **Enrollment in this Program**

To begin the enrollment process, you will submit these documents to [affiliates@hosting24.com](mailto:affiliates@hosting24.com)

- 1) a signed and scanned copy of these terms and
- 2) a scanned copy of your passport.

Upon registering as an affiliate on our website, Your account will be instantly active in our program. We will evaluate your account in good faith to ensure you comply with all our rules and agreements.

### **Utilizing Links on Your Site**

As an affiliate website of Hosting24.com, you may use any form of promotion you choose, consistent with the terms of this Agreement. You may use banner advertisements, button links and/or text links to our site (the "Links"), however, you cannot promote our services by sending unsolicited emails. Any activity by you or on your behalf that we determine or reasonably suspect to be the result of an unsolicited bulk e-mail program will result in your immediate termination from the Program and your forfeiting of monies otherwise due to you hereunder. Allowable promotional links may contain Hosting24.com's trade names, service marks, and/or logos for display on your Affiliate Site. In utilizing the Links, you agree that you will cooperate fully with us in order to establish and maintain such Link or Links. A Link may only be visually modified with our consent.

### **Commissions**

We will pay you a commission based on the below structure:

One time \$45 - \$105 per sale commissions program type:  
\$45 for each "Silver", \$85 for each "Gold", \$75 for each reseller "Starter" hosting plan sale

and \$105 for each reseller "Business" hosting plan sale.

Lifetime commissions program type:

50% of any sale value until clients stops using our service.

The Commission Rate is subject to change from time to time, upon e-mail notice to you and commencing the 30-days following such notice.

#### **Commission Payment**

Commissions deemed due and owed to you under the program will be paid to you directly by Hostinger after any holding period of 30 days and in accordance with a regular payout cycle established by Hostinger. No commission will be paid for signups by you or anyone within your organization. No commission will be paid for affiliates who have not submitted to Hostinger a signed and scanned copy of these terms and a scanned passport copy. Hostinger reserves the right to only pay for referrals that are active. Active is defined by clients with a website and domain name pointed to a Hosting24.com's server with user uploaded content. Commissions can be earned per each new client referred through the unique affiliate link or coupon code.

#### **Responsibility for Your Site**

You will be solely responsible for the development, operation and maintenance of your site and for all materials that appear on your site. We shall have no responsibility for the development, operation and maintenance of your site and for all materials that appear on your site. You shall also be responsible for ensuring that materials posted on your site do not violate or infringe upon any laws, including but not limited to 18 U.S.C. Section 2257, or the rights of any third party (including, for example, copyrights, trademarks, privacy, or other personal or proprietary rights), and ensuring that materials posted on your site are not libelous or otherwise illegal. You must have express permission to use another party's copyrighted or other proprietary material. - Provide inaccurate or incomplete information to Hostinger concerning your identity, address or other required information;
- Attempt to cheat, defraud or mislead us in any way;
- Misrepresent to the public the terms and conditions of our sites or your sites;
- Engage in popup advertisement network activities;
- IFrames may only be used on pages or sites in which the other content represented on the site is related to Hosting24

You are free to bid on PPC networks for keywords related to Hosting24.com with the intent to direct traffic to Hosting24.com

#### **Term of the Agreements**

The term of this Agreement will begin upon our acceptance of your Affiliate Program Application and will end when terminated by either party. Either you or we may terminate this Agreement at any time, with or without cause, by giving the other party notice of termination. Notice by e-mail, to

your e-mail address on our records, is considered sufficient notice for to terminate this Agreement. If this Agreement is terminated because you have violated the terms of this Agreement you are not eligible to receive any commissions payments, even for commissions earned prior to the date of termination. If this Agreement is terminated for any other reason, you are only eligible to earn a commission on sales occurring during the term of the Agreement, and commissions earned through the date of termination will remain payable only if the related orders are not canceled or returned. We reserve the right to withhold your final payment for a reasonable time to ensure that the correct amount is paid.

#### **Modification**

We may modify any of the terms and conditions contained in this Agreement, at any time and in our sole discretion. Notice of any change by e-mail, to your address on our records, or the posting on our site of a change notice of a new agreement, is considered sufficient notice for notifying you of a modification to the terms and conditions of this Agreement. Modifications may include, but are not limited to, changes in the scope of available commission fees, commission schedules, payment procedures, and Affiliate Program rules. All such modifications shall take effect 48 hours after we serve notice as provided above, unless we indicate otherwise. If any modification is unacceptable to you, your only recourse is to terminate this Agreement. Your continued participation in the Affiliate Program, following our posting of a change notice or new agreement on our site, will constitute binding acceptance of the change.

#### **Limitation of Liability**

We will not be liable for indirect, special, or consequential damages, or any loss of revenue, profits, or data, arising in connection with this Agreement or the Affiliate Program, even if we have been advised of the possibility of such damages. Further, our aggregate liability arising with respect to this Agreement and the Affiliate Program will not exceed the total commissions paid or payable to you under this Agreement.
